#### Item 5.07 Submission of Matters to a Vote of Security Holders.

On June 4, 2020, Shutterstock, Inc. (the "Company") held its Annual Meeting of Stockholders (the "Annual Meeting"). As of April 17, 2020, the record date for the Annual Meeting, there were a total of 35,601,609 shares of the Company's common stock outstanding and entitled to vote at the Annual Meeting. At the Annual Meeting, 33,762,656 shares of the Company's common stock were represented in person or by proxy, and therefore a quorum was present.

Described below are the matters voted upon at the Annual Meeting and the voting results.

#### Proposal One - Election of Directors

At the Annual Meeting, the Company's stockholders elected the following Class II director nominees to serve on the Company's Board of Directors until the 2023 Annual Meeting of Stockholders or, in each case, until the director's successor is duly elected and qualified or, if earlier, his or her death, resignation or removal.
